1. (S/NF/SK) MISSION: Correctly acquire and describe the major gestalts (stage 1 phase two) of the site, Sherman Glacier, Alaska, training site 0179.
2. (S/NF/SK) VIEWER TASKING: Coordinates 6033/ 1303.
3. (S/NF/SK) COMMENTS: Viewer reported an physical inclemency of the flu. Viewer also had an advanced visual of a lake, and a bridge over water. After the session, viewer expressed frustration over the fact that site/session end was declared just as she started to feel site contact, ie. started to get (S2) sensory and visual perceptions. Her frustration is a result of the fact that she personally does not consider correctly decoding the ideograms as sufficient "proof" of psychic functioning. She does not feel that she has accomplished anything unless she starts to feel that she is bilocating.
4. (S/NF/SK) EVALUATION: Viewer acquired three major gestalts of the site: Land, mountains, and the motion of the glacier. She experienced some trouble with CRV structure: twice she forgot to objectify the feeling component prior to the B component also she didn't declare two AOLs until much after the fact. She stated that she is having some trouble with the feeling for water. She always picks up on the motion but rarely the fluidy. She said that when she now gets motion she wants to say water. As monitor I explained that she would need to learn to distinguish between the two more clearly since motion exists in more than water. Recommend that either more S1 sites containing water be included in the viewer's training and or perhaps a site the has a strong gestalt of motion that doesn't include water.


