TARGET CUE! PERSON

CUE: DESCRIBE LOCATION.

RESPONSE: I find myself standing on the edge of a high bank or cliff, overlooking a large body of water. It is cool and breezy. The shoreline appears to be rather rugged. Behind me the land is rather flat and grassy.

CUE! DESCRIBE THE PERSON. WHAT IS HE WEARING?

RESPONSE! The person is wearing a heavy wool, or flannel shirt. This shirt has a plaid design of red, grey, black and white. He is wearing a pair of heavy, long pants, dark in color, like blue jeans. He has on heavy high top shoes, or boots, and is wearing thick, brown-frame glasses (see sketch, page 1 of session).

CUE: IS THIS PERSON WEARING ANYTHING ON HIS HEAD?

RESPONSE: He is wearing a pair of heavy, grey wool, or cotton socks that have white toes and heels (comment: this individual definitely needs a change of socks at this time).

CUE! THIS PERSON IS ENGAGED IN SOME FORM OF ACTIVITY. DESCRIBE THE ACTIVITY.

RESPONSE: He is standing, with his back to me, acting, feeling, or doing something really crazy. His arms are flexed away from his body. He seems to be showing-off or acting-out for someone behind him (see sketch A., page 3 of session).


RESPONSE: The first letter has a vertical line with a downward curving attachment, like possibly a b, or a D (see sketch A., page 5 of session).


