1. (S/NF/SK) TASKING: The Interviewer was provided with a sheet of paper on which the following tasking had been handwritten: Interviewer/Monitor Tasking I-3. Describe the target/activity

provided none of the above cuing or data prior to the session except the encrypted coordinates, as per Extended Remote Viewing (ERV) protocols, to preclude inadvertent geographic cuing. No other cuing or descriptive data was provided to Source.

2. (S/NF/SK) During the actual session there were no reportable anomalies or incidents which may have affected or influenced the data provided by Source except that which is cited above. This session was conducted in its entirety utilizing ERV protocols.

## 3. (S/NF/SK) SUMMARY:

a. (S/NF/SK) The following narrative, contained within quotation marks, is an abridged copy of Source's post-session written summary. This summary has been editorialized, (as indicated), by the undersigned for clarity, grammar and structure. The actual unabridged summary is maintained in the mission field dossier at this location along with any other material produced during the session, i.e., sketches, notes, etc. BEGIN SUMMARY:

"I sensed a circular area...movement... (and) a structure, either

manmade or natural. I think it was a natural structure used by man. I felt that at this time I was underneath (underground) and I felt (sensed) dirt... (and) men moving about, walking, observing, overseeing. (Inside there were) men and two important areas. The first (gave an impression of) lighting coming from the floors. I (perceived) men being looked at (inspected?) and after they were looked at they left. (There was) a darker area. This area was deeper down under (the structure). It was dark. (I perceived) that men met here (to discuss plans) and the plans were simple. (In this area I perceived) simplicity, rough walls, no hangings, no papers, no maps. Nothing. Men met here and made fast decisions. (There was another impressions of) a small group of men (who) made up a force. This force (was) not well known even to the larger force. (There was a strong impression of) internal damage, a fast strike (by this force?). (There is) an object that was rotating and moving backwards. I sensed myself riding backwards (with this object). This object fired and then the firings vanished. This object could not hit high altitudes but could hit fast. It was moving backwards. (In the future) this object looked better and (was) bigger. I could see men packed and leaving (the area of this object). They were walking and leaving the area. Now the object was working correctly and it was still not hitting high altitudes but it could reach out at longer distances. (I had a final impression) of being on a vehicle which reminded me of a train. I could see compartments and I could see a pouch or pocket that had something to do with a future event. I sensed that a change in the future (was associated with this pocket) and a man being elevated" END SUMMARY.

b. (S/NF/SK) During the actual session, Source reported other data which may impact on the final assessment of this target. That data is listed below in raw unevaluated form:

(1) (S/NF/SK) The circular area referenced early in the session was also described as having an "edging, a rim, slanted...inside (there is) dirt". Additionally, within this circular area, Source perceived that, "sometimes (there's) a shooting off within the area and sometimes I can see (it)...gives the area higher (heat), it makes it hotter...red flames then they disappear...".

(2) (S/NF/SK) The area was described by Source as, "isolated, (a) natural area...looks very natural (but) has a hidden meaning (camouflage?)...not always busy, not consistently being used...people are sent here...".

(3) (S/NF/SK) Source reported an impression of a structure which was further described as, "a round, big smooth, manmade, in a natural setting, enter from under, very low structure, so big but

the entrance is so small...nothing fancy here...a hollowness inside, not busy, not crowded, only here for special purposes...a maze...a feeling that I'm in dirt...this area looks like part of the scenery...one would not expect it, it's in an open area but from a distance it looks like the scenery...".

(4) (S/NF/SK) When Source was directed to locate, "an object of importance at this site", She began describing, "something moveable, spinning, part of it is shooting off, coming up and around...the shooting off doesn't go very high, damaging at very low levels (altitudes), damaging up close...it doesn't have the power from far away but the movement is fast and makes up for it...".

(5) (S/NF/SK) Source also describe other characteristics of "the device" but it was not certain that this was the same device cited above. In this second series of descriptions the "device" was described as, "round, spinning, backwards, firing out, moving around, black, heavy interior, there's a moveable inner working that can spit out and make the boom...it only fires low but it's fast...You bring it out in the open...it doesn't need a person, it can go by itself...it doesn't go high so it doesn't give (a) high threat but the threat is intended...".


(6) (S/NF/SK) Source's description of the "occurrence" and the future use of this device were a bit sketchy and included, "men walk away, the device stays there, remains after the fact...it will be straight, more precise, much precision, a straight line...it seems that you will be able to see the device in the open...much more refined, reaching out, (it) will be able to emit out better, (it) will move in a side-circular way and no longer backwards, it will be circular, able to reach out at further distances, more precise, inner workings will fit better...no problems...".

(7) (S/NF/SK) It was unclear as to the meaning of Source's late references to another vehicle, "like a train", in which She reported, "compartment, a side or a box, something hidden, putting in...everything will be normal...there is a change here, a small change which makes a big difference, (it) will not be caught...will be unnoticed...". Source was unable to clarify the meaning of "the change".

4. (S/NF/SK) OPS FEEDBACK: Source's description of a barren area and the use of some type of weapon and the possibility of another device associated with this weapon were indicative of a successful target acquisition. No conclusions can be drawn at this time from Her descriptions however, in the next session, She will be specifically targeted against the occurrence. By this method, it is hoped that more definitive data can be obtained concerning the

actual EEI and the related "event". At that time efforts will be made to separate the confusing components of this session to ascertain whether Source is reporting on various pieces of equipment or one item with several perceptions.
