GRILL FLAME SECURITY AGREEMENT

I, Melvin C. Riley, understand that the highly sensitive and classified information I have, or am about to receive as part of the GRILL FLAME Program belongs to the United States Government. I understand that disclosure of this information is punishable under Title 18, Section 798, U.S.C. "Disclosure of Classified Information," June 1948 as amended.

I do solemnly swear that I will never divulge, publish, or reveal by word, conduct, or by any other means such classified information or knowledge, except in the performance of my official duties, and as specifically authorized in writing in each case by the appropriate agency of the United States Government.

I understand that no change in my assignment or employment will relieve me of my obligation under this agreement and that the provisions of this agreement will remain binding upon me even after the termination of my services with the United States Government.

I take this obligation of my own free will, without any mental reservation or purpose of evasion.

DATA REQUIRED BY THE PRIVACY ACT OF 1974  
(5 U.S.C. 552a)

1. Authority: National Records Act, 44 U.S.C. 3102; E.O. 9397, Numbering System for Federal Accounts Relating to Individual Persons, November 22, 1943.
2. Principal Purpose: To maintain a record of those individuals who have or have had access to GRILL FLAME information through the use of their name and/or Social Security Number.
3. Routine Uses: The Social Security Number is to be used to identify the individual, and the information is to be retained strictly within the Program.
4. Mandatory or Voluntary Disclosure: Information is disclosed on a voluntary basis, but withholding information will render it impossible to grant an individual access to or participation in the Program.

INFORMATION ABOUT REMOTE VIEWING FOR PARTICIPANTS

1. (S-ORCON) Remote Viewing (RV) is the intellectual process by which a person perceives characteristics of a location remote from that person; it does not involve any electronic sensing devices at or focused at the target site; nor does it involve classical photo interpretation of photographs obtained from overhead or oblique means.
2. (S-ORCON) RV has been performed by certain individuals successfully and we are confident other individuals can do it too.
3. (S-ORCON) The general outline of RV procedures is at paragraphs six and seven of the AMSAA RV Protocol.
4. (S-ORCON) You as a remote viewer may perform one or more types of RV.
5. (S-ORCON) The maximum frequency you may be asked to perform RV is two sessions per day, but no more than three sessions per week.
6. (S-ORCON) You may choose not to perform RV at a particular time without prejudice to further participation in this task, or you may discontinue participation permanently at any time without any prejudice.
7. (S-ORCON) The purpose of this project is:
  - a. To establish a program using psychoenergies for intelligence applications.
  - b. Specifically, utilizing that field of psychoenergies referred to as Remote Viewing.
8. (S-ORCON) There is no evidence of any adverse physical, psychological and/or social effects on the remote viewer from participation in this activity.
