SUN STREAK INDOCTRINATION CLASSES OF PYSCHOENERGETICS

PSYCHOENERGETICS INCLUDES CLASSES OF HUMAN CAPABILITIES GENERALLY REFERRED TO AS PARAPSYCHOLOGICAL PHENOMENA.

1. REMOTE VIEWING/EXTRASENSORY PERCEPTION
2. REMOTE ACTION

VIA UNDEFINED TRANSMISSION

SWITCH PLATE INDOCTRINATION LEVELS OF ACCESS

SWITCH PLATE/SUN STREAK HAS THREE LEVELS OF ACCESS

- A. HIGHEST LEVEL - INCLUDES SUN STREAK/
SWITCH PLATE COVER, SPECIFIC LOCATION,
IDENTITIES OF PROGRAM PARTICIPANTS,
AND OTHER SENSITIVE PROGRAM DATA
- B. NORMAL ACCESS LEVEL - INCLUDES PROGRAM
DESCRIPTION, CAPABILITIES, REQUIREMENTS,
FEEDBACK, EVALUATIONS AND OTHER
PERFORMANCE DATA
- C. ADMINISTRATIVE LEVEL - FOR PERSONNEL
WHO MUST HANDLE SUN STREAK/SWITCH PLATE
MATERIAL, BUT HAVE NO SUBSTANTIVE
NEED-TO-KNOW

SWITCH PLATE INDOCTRINATION KEY SECURITY PRINCIPLES

THE KEY PRINCIPLES WHICH GOVERN THE SECURITY OF BOTH THE SUN STREAK AND SWITCH PLATE COMPARTMENTED SPECIAL ACCESS PROGRAMS ARE:

1. PROGRAM MATERIAL IS ONLY TRANSMITTED OR COMMUNICATED POINT-TO-POINT BETWEEN NAMED, CLEARED INDIVIDUALS
2. TRANSMISSION/COMMUNICATIONS MEANS MUST ENSURE THAT NO UNCLEARED INDIVIDUAL WILL HAVE ACCESS TO THE MATERIAL AS IT PASSES POINT-TO-POINT BETWEEN NAMED, CLEARED INDIVIDUALS
