



----The target is a large structure characterized by the presence of a triangular peak positioned at the top of the building.

----The structure resembles a tower and if can be dangerous.

SOURCE 049:

----The target involves the presence of a radiation type activity.-

----The presence of vehicles (trucks) was perceived s being associated with the target.

SOURCE 079:

----The target is a natural setting with two small structures sitting close together.

----There was the presence of a circular object (not further defined).

----The target appeared to have historical significance.

----Liquid (water) is present. There is the presence of brown tubular objects and the discernible activity of fast motion.

----Vehicles are or could be there.

GENERAL SUMMARY:

There is insufficient correlation in source reporting to arrive at a general consensus of the target. Source summaries must be read individually to determine coorelation to the beacon target.
