Site involves a hard, rusty dim, dark, hot, smelly, stuffy structure moving sluggishly on water; there is a throbbing, rhythmic sound that is so low it's almost only a vibration that is suggestive of monotonously running machinery. Grey, black, and reddish/orangish streaks are primary colors, along with dingy white. Red, green and white are also significant colors. Structure, perhaps a vessel, is plodding, nondescript, pushing, gasping, wheezing, low budget, like it's old and worn out. Doesn't stand out, aims to appear innocent. It's very nondescriptness is considered an asset. "Flag of convenience" is a concept associated here. Seemingly commercial. A person associated with it is in dim, stuffy circumstances--cooped up. Other people are here with apparent weapons—but usually only present one at a time. There may be five of these types. Two groups are present--those who belong with this "vessel", and those who are temporarily here w/subject of interest. an AKM. Keeping this "vessel" wandering aimlessly while appearing to be going somewhere all the time is difficult to continue doing, but no plans are present to put back in to port. idea is to keep subject away from upheaval where he might get "lost" from those who have him. AOL/S Tyre. Person seems to have his time divided between a small, stuffy dark room in builtup portion (superstructure) of "vessel" and a larger, darker, hollower deep down in portion of it.
