
1. (S/NF/SK) MISSION: See tasking data sheet, attached.

A personality identified as "B-10" is suspected of playing a significant role in the abduction. ## 2. (S-SS) Cueing:

a. Describe the target person and surroundings.

## 3. (S-SS) Results:

a. PERSON: The target person is a male. There were repeated and strong impressions that he has a large and muscular stature. His face was perceived as being squarish and muscular. All impressions of this person included the perception that he was very well dressed (suit), and that his clothing was very neat, without wrinkles of any kind. He seemed to be sitting quietly inside a semi-dark structure.

b. SURROUNDINGS: All perceptions of his surroundings indicated that he was in a place which seemed totally uncharacteristic for his personal appearance. The area appeared covered with heavy vegetation. The structure in which he was located appeared to blend in with the surrounding vegetation, (AOL: like encroaching jungle or a vine-covered structure). The structure itself appeared to be ramshackle, and appeared to have light coming in between the boards of the walls (AOL: like a falling-down shed or barn).
