The fence is painted in large "blobby" patterns (see Fig. 2) of pastel green and pastel turquoise colors (AOL: like you might see at a day-care center). The place is clean and reat, but has beginning to fall into disrepair (the grass is getting very tall, etc.). The place is otherwise deserted.



Large fence connected to a structure.



