
Site is a group of large, flat-roofed structures suggestive of some sort of physical-plant facility or industrial site. It lies near a large, ocean-like body of water and is surrounded by a significant boundary/security fence made of metal. The terrain is flat-to-slightly rolling, is open, with few if any structures in the area outside this facility. The surface of the ground reminds me of snow--it is light colored with little humps or ripples in it, but it doesn't seem to melt. Reminds me also of sand. It is night or late evening, but inside the compound it is very brightly lit, with powerful flood and yard lights. Impression is that activity here continues on a 24-hour basis. There are hissing sound, industrial noises, and machinery sounds. It is official, secured, and closed to outsiders. There are long, tall, hollow, thin structures with black rings painted around the tops of them that suggest smoke or exhaust stacks. Volumes of water are needed for the process involved. Water is taken in, used, then discharged. When it leaves it is not in good shape; it is noxious, nasty tasting, and smelling, probably not healthy at all. There are tanks for liquid/gases present. Also many pipes running parallel. The "stacks" are for fumes, and heat/exhaust. Whatever is manufactured here will be held until there are sufficient quantities on hand, then it can be shipped elsewhere, or remain stored here. There is a sense of bulk, perhaps even liquid shipment. It must be handled with extra precautions because hazardous conditions apply to the material. It has a sharp smell--chemical--oily--reminds me of 2,4-D herbicide. Another smell is present that is sharp, sweeter, cloying--so much so that it becomes very unpleasant. It reminds me somewhat of a vinegary sort of smell. The material is corrosive, but is not used as a corrosive. Inside, the tanks that contain it are lined "like" with porcelain. It is white in color, very smooth, and not interactive--inert to chemical action.






