1. (S/NF/SK) MISSION: To access and describe an event which is suspected to have taken place at about 1830 hours (local), on 4 April, 1987.

2. (S/NF/SK) VIEWER TASKING: Stage I: encrypted coordinates. Well into Stage IV: "The target is an event which has already happened. The coordinates include cueing for both the time of the event and the site location."

3. (S/NF/SK) COMMENTS:

a. Inclemencies: None declared.

b. 003 appeared to have no trouble accessing and describing the site. A cursory look was made into each of the EEI requirements, but the target was not probed in great depth. Near the end of the session, the AOL of "drug trafficking" began to nag at 003, so the session was ended. Deeper probing into each of the EEI requirements will come in the following sessions.

Site is a structure that is flat on top, white, masonry, in an opening amongst thick, green vegetation. It is surrounded by a wall/fence combination, and guarded by several people. There is an impression of several people gathering together here planning something--they go inside to talk over something of mutual interest to all of them. The talk is about several things--certain specific orchestrated actions to be performed, and also about "policy" as to how to represent what happens, A/S as in "cover," or "deniability," or "alibis," or "justification." Several convoluted game plans are interwoven. Some of the people involved seem to be non-US, some US; other languages are spoken, but English predominates. People don't wear ties, but rather open shirts, that are white, with dark "like" sportcoats. At least some of the people are shorter, dark complected; some are easily provoked. What they are anticipating would be welcomed by some, and very unwelcome to others in the larger community, maybe even world. There is a sense of international implications in which the US is involved--not as an actor, but rather as one acted upon. What is going on here depends on confidentiality--it can only function if more powerful agencies external to it don't know for sure what's going on.


Presently, the location is quiet, busy, but not extremely so--"like" a sort of low-key "command center" or "base of operations," keeping its finger on the pulse of what is continuing or proceeding. A sense of contentment with how things are proceeding thus far. What's going on at this location is not particularly significant. There is a person involved with the site who is short, non-Anglo but lighter-skinned than many 3rd world people. He has a pock-marked face and doesn't wear glasses. He has a cold, cruel sense of humor.

Some aspect of the activities occur within the US, as well as in other places. Strong feeling that location and activities are primarily confined to Western Hemisphere. It all involves more countries than where the first location is and the US, but not more than five countries altogether. Activity is covert (though there doesn't seem to be any governmental or official feel about it--i.e. in some sense private activity.) but there are significant resources available to support it. It is not beneficial to US interests. Activity involves clandestine meetings between parties involved. There's not a great concern they'll be discovered--they believe they will probably get away with it. However, disclosure would seriously disrupt goals.
