SUMMARY OF INFORMATION

TARGET APPEARS TO BE AN ENCLOSED COMPLEX, CONSISTING OF A LARGE, MULTI-STOREY BUILDING WITH SEVERAL SMALLER SUPPORT TYPE BUILDINGS. THE COMPLEX AREA APPEARS TO BE SURROUNDED BY A CHAIN-LINK TYPE SECURITY FENCE. ADJACENT TO THE STRUCTURES IS A RECTANGULAR, OPEN, COURT-LIKE AREA WHICH IS SURROUNDED BY A SEPARATE CHAIN-LINK TYPE FENCE. THE COMPLEX IS SERVED BY ROAD, THERE IS ALSO SOMETHING RESEMBLING A RAIL LINE NEARBY WHICH ALSO MAY SERVE THIS FACILITY.

AREAS NORTH AND TO THE WEST OF THIS COMPLEX APPEAR TO BE RESIDENTIAL IN NATURE. THE AREA TO THE SOUTH IS OPEN AND GRASSY, THERE IS A LARGE BODY OF WATER TO THE EAST AND IMMEDIATELY ADJACENT TO THIS COMPLEX.
