1. (S/NF/SK) MISSION: Determine remote viewer's ability to collect foreign intelligence against a target document shielded from normal perception. Also, determine the location of the target structure in which the document is located.
2. (S/NF/SK) VIEWER TASKING: Determine location of the target structure via coordinates 174301/868853. Determine location via maps accessed in adjoining room and place an X in the appropriate area.
3. (S/NF/SK) COMMENTS: The CRV room was accessed from the ERV room while 079 was in session. The document was believed to be located in the immediate area of Cameron Station in an area bounded by Stevenson Park (Watergate at Landmark) and Van Dorn Street. Because of 079's selection of "H-1" (Value of 1 being assigned to Cameron Station by the undersigned), it is believed that Cameron Station played an important role in this document. Perhaps it is a Det O, USAOG, IIR, with reporter number prefix 2201.

DURING THIS SESSION, I WAS ASKED TO LOCATE THE DOCUMENT. THERE ARE SEVERAL LANDMARKS WHERE THE DOCUMENT IS. I FIRST SAW A VERY LARGE, TALL CHURCH AND I RECEIVED THE IMPRESSION OF MOSAIC. BEHIND THE CHURCH, I COULD SEE A VERY LARGE, ROUND, BROWN LOGO THAT LOOKED LIKE A GIANT COIN. THERE WAS A MAN'S PICTURE ON IT. THE THIRD LANDMARK WAS A SCHOOL.

WHEN COMING TO THE AREA WHERE THE DOCUMENT WAS, I COULD SEE A CIRCULAR AREA AND IT LOOKED AS THOUGH MEN WERE WORKING OUTSIDE. I SAW A LOW, WHITE STRUCTURE AND IN FRONT OF THE STRUCTURE THERE WAS A SIGN THAT SAT ON THE GROUND AND IT HAD GREEN LETTERING ON IT. I COULD SEE GREEN GRASS AND LONG GATES. IT WAS QUIET AND PEACEFUL HERE. SOME OF THE LAND WAS ROCKY AND PEOPLE CAN GO HIKING AND BIKING HERE. THERE WAS A THICK, DIRT ROAD. LATER ON DURING THE SESSION, I SENSED THAT THERE WAS A ROAD THAT PARTED OR DIVIDED. I DO NOT KNOW IF THIS WAS THE SAME ROAD OR IF THIS WAS A DIFFERENT ROAD. I SENSED A SMALL BRIDGE NEARBY. IT WAS BREEZY HERE. I ALSO SENSED THAT THERE WAS SOME BLACK DIRT OR BLACK GROUND NEARBY.

WHEN TRYING TO ACCESS THE DOCUMENT, I SENSED THAT IT WAS IN THIS WHITE STRUCTURE. NOT TOO MANY PEOPLE WORK IN THE WHITE STRUCTURE. I SENSED NOT MORE THAN 100. THE DOCUMENT WAS IN A DARK ROOM AND IT WAS IN A CONTAINER. AN OLDER CIVILIAN MAN HANDLES THE DOCUMENT.

SOME OF THE IMPRESSIONS I RECEIVED DURING THIS SESSION WERE

MEN BEING PULLED BACKWARDS OR MEN BEING PUSHED OR MOVING ON. I RECEIVED THE IMPRESSION OF STEERING, TAKING TIME, TIMING, AND WATCH. I ALSO RECEIVED THE WORD "BLANK."

OVERALL, I FELT THE AREA THAT THE WHITE STRUCTURE WAS IN WAS MILITARY BUT NOT TOP MILITARY. I COULD NOT SEE ANY FLAGS. THERE WERE OTHER STRUCTURES NEARBY WHICH SERVED OTHER PURPOSES. SOME PEOPLE COME TO THIS AREA TO EAT AND DRINK.

WHEN ASKED TO ACCESS THE MAP AND TRY TO LOCATE WHAT AREA I WAS IN, I REPORTED IH. (B) - For map labeled B

AFTER THE SESSION WAS OVER AND I LOOKED AT THE MAP, THE AREA WAS CAMERON STATION. WHEN TRYING TO EVEN PIN POINT THE AREA AGAIN ON TWO DIFFERENT MAPS, I KEPT COMING TO VAN DOREN STREET.
