- 2. (S/NF/SK) VIEWER TASKING: 011 was informed at the outset that this target had been worked before. The session began in Stage 4 without a cue (however, the coordinates were placed outside of the S4 matrix at the top of the page and the viewer was informed that place was desired). This strategy did not pan out and 011 was directed to locate a landmark. This tactic was also of questionable value and both monitor and viewer decided to review earlier session transcripts so as to reacquire the original "signal line". Movement exercises were then employed in an attempt to get an overall description of the area in the immediate vicinity of the assumed target structure.
- 3. (S/NF/SK) COMMENTS: This was a tough session; much AOL had to be worked through. It is this monitor's opinion that, based upon the data, the document is either located near the Mall (Washington, DC) or is in the SCIF at Ft Meade--which location is AOL remains to be worked out in subsequent sessions.
