Notes on meeting with [redacted] (DIA/OGF) 30 Jan 95:

[redacted] is Office of Ground Forces, DIA [redacted]. His component became responsible for management oversight of the DIA Stargate program about a year ago. It is currently LIMDIS, formerly SAP (while in the Army?). It has been at DIA since the late 80s [88-89?], and may have been in the Army prior to that, but it is not clear that there is a continuous thread to follow as these may have been independent programs. [redacted] is DIA program manager, and he has three remote viewers under his supervision housed at Ft. Meade. [redacted] discussed the various program parts from his perspective which are loosely defined as R&D, Operations, and Foreign Assessment. Other meeting attendees: [redacted]

R&D:

The principal player in DIA's R&D effort has been Ed May of SAIC, [formerly of SRI?]. [redacted] was unable to state what the particular R&D objectives were, although he later mentioned a couple of examples. The program is apparently out of money for R&D at this point. However, [redacted] recently received an exhaustive unclassified report from Ed May addressing the research issues of the program which [redacted] used in part as the basis for a LIMDIS classified report he wrote and sent to CMS; apparently [redacted] report covers only the DIA Stargate program, and was generated in response to the SAC CDA by the deadline of March 1. [I requested copies of both Ed May's unclassified document and [redacted] report]. [redacted] said CMS had a copy of the report and that a copy is on its way to Congress.

In addition, some 40 papers by Ed May relating to the R&D aspects of the program are unclassified. These should all be part of the R&D review we conduct. We agreed to get from Ed May all the unclassified material we could.

Operations:

These consist of [redacted] directing the remote viewers to "access and describe the target" based on a limited description of the target's context. [redacted] had not actually witnessed an "operation". We agreed to go to Ft Meade and meet the viewers ourselves.

[redacted] report is also supposed to address the declassification of the program. According to [redacted] based on the discussions which took place on this issue, it is his opinion that nothing in this program should be classified except US Government Sponsorship [why?]. He says that there is no threat to national security involved, no sensitive sources and methods. The problem may be the "giggle factor" in that this program could be an embarrassment to some. We stated that we intend to push the declassification issue hard.
