(C) Last night, 9 May 95, I received a call from [redacted] a former member of this Activity, who advised that he was called by a Janet Klein, ABC News "20/20", who was doing background research for "20/20" with regard to Army sponsorship of our mission area. Janet Klein also asked for the phone numbers of [redacted] [redacted] a former member of this Activity. According to [redacted] she tried to ask questions every which way in order to elicit a response. Janet advised [redacted] that she had heard that [redacted] did readings on the side and that she would call her for a reading. It should be noted that [redacted] provided no phone numbers. [redacted] did provide her with info on his company and stated that coordinate remote viewing (CRV) was the basis for his activities and nothing more. [redacted] asked her if she had spoken to [redacted] a former member of this Activity and a retired US Army officer, and she stated that she had not because she was looking to speak to others who could provide more accurate information. It was [redacted] opinion that Janet Klein was doing background research for an expose. Janet also offered a tidbit of info that she had obtained data to show that Army personnel demonstrated their capability in Congress and at the White House. She also passed on that last month in Washington State, a U.S. Senator, nfi, had on TV stated that he had funded the Army program.
